The puppy you have purchased from **Prairie Pups Direct, dba prairiepupsdirect.com** is guaranteed to be healthy at the time of purchase. The puppy is current on vaccinations and de-worming at the time of purchase. It is the responsibility of the buyer to keep the puppy's vaccinations and de-worming current until the puppy is 18 weeks old, then once annually.

10-Day Guarantee

Prairie Pups Direct, dba prairiepupsdirect.com guarantees the puppy for 10 days from the date of purchase against parvovirus, distemper, leptosporosis, hepatitis, par influenza, corona virus and bordetella. If your puppy contracts any of these within the ten-day warranty period pupsdirect.com must be contacted at once. If the puppy should die from one of these illnesses within the ten-day period pupsdirect.com must be contacted within three days of the death. A replacement puppy of the same breed and sex will be provided from the next litter provided that pupsdirect.com is provided with a written veterinary statement as to the cause of death and have the puppy sent to a major university for posting.

One Year Guarantee

Prairie Pups Direct, dba prairiepupsdirect.com guarantees for one-year against any hereditary or congenital disorders that may interfere with the puppy's ability to lead a normal life. This one-year guarantee covers such disorders as heart murmurs, skeletal abnormalities, luxating patell's, hip dysplasia or blindness. In the event of such an occurrence, pupsdirect.com will replace the puppy under the same conditions, as stated above, providing a written veterinarian statement is submitted to pupsdirect.com within ten days from the date of diagnosis as to the nature of the problem. All shipping cost for the replacement puppy is the buyer's responsibility.

Both the buyer and the seller, prairiepupsdirect.com, of the puppy(s) hereby understand that the buyer is responsible for any and all veterinarian cost of every kind and nature after the date of purchase including vaccinations and de-worming. If for any reason there is an exception made the buyer shall contact the seller, prairiepupsdirect.com, and the seller, prairiepupsdirect.com, will have full say in determining if a refund will be given. Any amount agreed on in excess of \$50.00 for a veterinarian bill must be given in writing by the seller, prairiepupsdirect.com, to be valid. No other guarantees are made or implied by prairiepupsdirect.com except those stated in this written health guarantee. All guarantees are strictly on a replacement basis.
